### 什么是食品接触材料新品种？

- 新材料（树脂，聚合物等）
- 新添加剂（着色剂，塑化剂等）

### 法规参考

- 中华人民共和国食品安全法
- 食品相关产品新品种行政许可管理规定
- 食品相关产品新品种申报与受理规定

### 如何判断食品接触材料新品种？

若食品接触材料未列入或使用范围超出以下法规，则是新品种，需进行申报：

- GB9685-2008 《食品容器、包装材料用添加剂使用卫生标准》
- 聚己二酰丁二胺等 107 种可用于食品包装材料的树脂名单
- 卫生部、卫计委批准作为食品包装材料用添加剂的公告
- 相关卫生标准 (如: GB 9691-1988食品包装用聚乙烯树脂卫生标准)

## New Food Contact Substances Notification

### What is New Substance for Food Contact Material?

New raw material (such as resin, polymer and etc.)  
 New additive (such as coloring, plasticizer and etc.)

### Regulation Reference

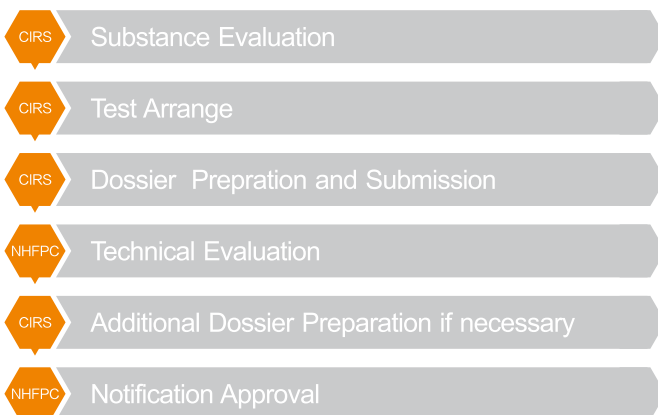
- Food Safety Law of the People's Republic of China
- Administrative Permission Stipulation on New Food Related Product
- Stipulation on Application and Acceptance of New Food Related Product

### How to Confirm if a Substance is New?

If a substance is not in the positive list or its application scope exceeds the positive list as following, it is a new food contact substance.

- GB9685-2008 Hygienic standards for use of food additives in food containers and packaging materials
- The List of 107 Resins that can be used in food packaging materials
- Notices of newly approved food contact additives and resins issued by MOH or NHFPC
- Hygienic standards for raw materials (for example: GB 9691-1988 Hygienic standards for polyethylene resin used as food packaging material)
