



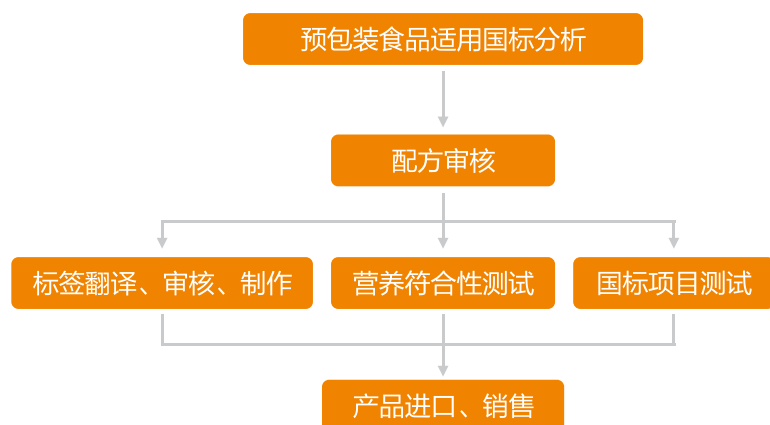

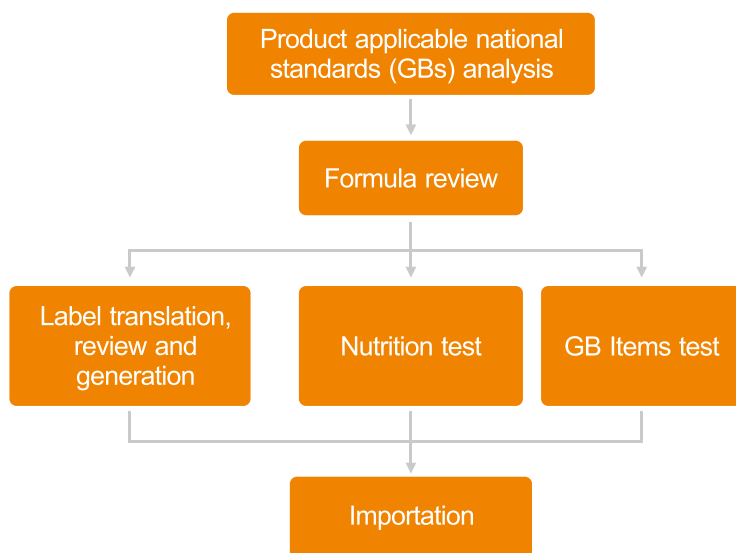
Prepackaged Food Regulatory Compliance in China
